 Responsible for the completion of property safety inspections on behalf of the Housing Landlord Compliance Service, ensuring premises are maintained and legal and corporate standards for Fire and Health/Safety are met. Acts as the fire safety expert (Housing) and advises Senior Management and elected Members. Failure to undertake statutory inspections could results in death, injury, structural damage, criminal proceedings, as well as reputational damage for Somerset Council.

Operational Service Delivery	 Undertakes statutory compliance checks for the Authority's housing stock. Undertakes inspections in occupied properties, which include entrance 		
	doors, balconies, and domestic water risks. Inspects building structures, determining fire safety strategies following site visits and reviewing building materials used, their suitability for purpose and workmanship of the installers.

Dimensions of Role

The Housing Compliance team has responsibility for over 6000, council owned buildings. The role must provide reassurance to the authority that the retained housing stock are at, or above, the legal minimum safety requirements.



Following the tragedy at Grenfell Tower, fire safety has become an area of significant heightened risk, previously general health and safety advisors had reviewed fire safety measures as part of a general role, this has proven to result in substandard assessments being undertaken due to the complexity of the subject area.

Buildings vary in size and complexity from small two-unit dwellings to multi-block sites containing extremely vulnerable residents. Significant understanding of housing, the types and complexity likely to be encountered, including dealing with individuals who may pose a risk during a visit and types of mitigation required.

Assessments need to accurately assess their construction, likely areas for voids and vents, recognised control measures, roof space compartmentation, attention to detail is paramount as errors can result in significant harm to a resident, their families, and the wider community. In addition, litigation both statutory and civil, reputational damage and loss of income are all credible risks.
