<ul style="list-style-type: none"> • Work in the Community Participation Workstream of the HDRC team, which seeks to improve lives in Somerset in partnership with communities and organisations representing, supporting, and serving them. • Draw on your personal knowledge and lived experiences to shape the co-development of projects from the start to end. • Participate in research and evaluation training, support, and capacity-building activities. • As a member of the HDRC team, work with people with lived experience of relevant health and wellbeing issues to co-develop and implement research and evaluation projects in Somerset, including gathering, analysing, and sharing information. • Participate in and provide support to members of the Lived Experience Advisory Partnerships (LEAPs) and Lived Experience Advisory Research Networks (LEARNs) within the HDRC to increase community engagement and raise awareness of community-based participatory research and evaluation.

Project/Programme management

- Support the evaluation of the Community Co-Researcher role; the Community Participation Workstream and the HDRC programme.
- Share research findings by working with the HDRC team to prepare posters/ research papers for meetings, conferences, and publications accessible to a wide audience including local communities.

Creativity and problem solving

- Use own initiative to engage with and support approaches to promote participatory networks for research and evaluation across Council functions and the VCFSE sector.
- Work with all partners to develop creative solutions to issues and challenges that emerge in the course of this work.

Financial/budget management

- Support the HDRC team with managing remuneration for public participants in research and related activities.
- Work within allocated budgets to support the delivery of projects and initiatives.
- Performance frameworks / monitoring and evaluation.
- Support the evaluation and ongoing improvement of the Community Participation Workstream and the wider HDRC.
- Co-produce reports with the Community Participation Workstream team.

Commissioning and contract management

- Work with the Community Participation Workstream team to identify community research priorities and to develop research funding applications.

Communication

- Champion the Co-Researcher role, the HDRC, and the Community Participation Workstream – internally with colleagues across all Council functions, and externally with partners and communities.
- Work with the HDRC Communications Workstream to improve how the HDRC communicates to the wider public.
